In accordance with Section 20 of the Planning and Development Act 2000 (as amended), Tipperary County Council has screened the Proposed Material Alterations and has determined, in the case of all three LAPs, that Strategic Environmental Assessments (SEA) and Appropriate Assessments (AA) are not required with respect to the Proposed Material Alterations. The SEA and AA Screening Reports and Determinations include information on the likely significant effects on the environment of implementing the proposed material alterations.

Please ensure that no vexatious, libellous or confidential information, including confidential information relating to a third party (in respect of which the third party has not, expressly, or impliedly in the circumstances, consented to its disclosure) is included. The Planning Authority reserves the right to redact any submission or part thereof that does not comply with this requirement.
